Terms & Conditions

1. Entering the Competition:

- a. This Competition is governed by and subject to the following Terms and Conditions (**Competition**).
- b. Information on how to enter and prizes form part of these conditions of entry.
- c. Participation in this Competition constitutes an acceptance of these Terms and Conditions.
- d. The Competition Period (**Competition Period**) - Patrons who book a new meeting or conference with a minimum value of \$3000 from the 21 of November 2011 until 29 February 2012 will go into the draw for the chance to win the prize upon completion of the entry form. Entry is subject to qualification criteria as specified in section 1e.
- e. Qualification Criteria (**Qualification Criteria**) - Patrons may only enter the Competition by confirming, holding and paying (in full) for a new meeting or conference with a minimum value of \$3000 between 21 November 2011 and 29 February 2012. All bookings must be finalised by 29 February 2012 to be placed in the entry barrel before 12pm 29 February 2012. No other method of entry will be accepted. Bookings are subject to availability.
- f. The draw will take place at 12pm on Thursday 01 March 2012, Crown Entertainment Complex, 8 Whiteman Street, Southbank VIC 3006. The prize is described below.
- g. One winner will be drawn from the barrel and will win the prize described below.
