TERMS & CONDITIONS

3. Participation in this Competition constitutes an acceptance of these Terms and Conditions.
4. The Competition commences at 6:00am on Thursday 27 June 2019 and concludes at 8:45pm on Sunday 21 July 2019 (**Competition Period**).
5. For the purposes of this Competition, a day is defined as 6:00am to 7:55pm within each date of the Competition Period (**Day**).
