TERMS & CONDITIONS

THE OFFER

- 1. Crown's Birthday Bonus Offer (**Competition**) is governed by and subject to the following Terms and Conditions.
- 2. The promoter of this Competition is Crown Melbourne Limited (ABN 46 006 973 262), 8 Whiteman Street, Southbank VIC 3006 (**Crown**).
- 3. Participation in the Competition constitutes an acceptance of these Terms and Conditions.
- 4. The Competition commences at 6.00am on Friday 1 November 2019 and concludes at 5.59am on Tuesday 30 June 2020 (**Competition Period**).
- 5. This Competition is only open to residents of Victoria, Australia who are not prohibited from Crown for any reason in accordance with clause 31 who are:
 - Selected Member, Silver, Gold and Platinum Tier Crown Rewards Members (Members);
 and
 - b) Non-members who join Crown Rewards as a full Member during the Competition Period (Non-Members).
- 6. Non-Members who join Crown Rewards as a full Member during the Competition Period will thereafter be defined as Members and will have the opportunity to participate in the Competition in accordance with clauses 12 and 13.
