Prize Draws and Prizes:

There will be up to 16 winners determined in respect of this Competition.

Prize Draws

There will be 16 Prize Draws conducted. The Prize Draws will be held at 8.30pm on each Day of the Competition Period at the Main Casino Floor as follows:

The competition barrel at each Participating Venue will close at 8.15pm and all entries will be combined into one main competition barrel. The first valid entry drawn randomly from the entries received during the Barrel Open Period (**Draw Winner**) will have the opportunity to play Fortune Spin (**Promotional Game**).

On each Day of the Competition Period, at the conclusion of Draw the competition barrel at each Participating Venue will be emptied and all entries received for that Day will be discarded. Entries received in respect of each Prize Draw will not roll over to Prize Draws on subsequent Days during the Competition Period.
